REPRESENTATIVE LITIGATION

Swan v. Stoneman, Civ. No. 79-36 (D. Vt., filed February 2, 1979, <u>dismissed</u> September 12, 1979), <u>rev'd.</u>, 635 F.2d 97 (2d Cir. 1980), consent decree filed August 12, 1981, <u>sub nom Swan v.</u> Burchard

Class action of first impression nationally for declaratory and injunctive relief pursuant to 42 U.S.C. § 1983 alleging that lack of pretermination hearing under state vocational rehabilitation program deprived plaintiffs of rights under Rehabilitation Act of 1973 and Fourteenth Amendment. Secured reversal of dismissal for failure to exhaust administrative remedies. Case settled favorably with agreement by State to implement new regulations affording due process protections.

American Bank and Trust Co. v. Hermann, No. 79-146 (U.S. Bankruptcy Court, D. Vt. 1980)

- Decision by court after trial finding no intentional fraud in use of credit card and holding that intentional fraud, not fraud implied in law, must be shown under section 17(a)(2) of the Bankruptcy Act in order to bar the dischargeability of a debt.

Blake v. O'Rourke, No. 84-208 (D. Vt., filed June 27, 1984)

- Class action challenge to new federal-state regulations dealing with welfare benefits income calculations as violative of Supremacy Clause. Dismissed as moot following passage of new federal legislation.

Kendall v. Brock, 689 F. Supp. 354 (D. Vt. 1988) (successor lead counsel)

- Class action of first impression nationally for declaratory and injunctive relief alleging regulations of defendant United States Secretary of Labor allowing for termination and reduction of certain benefits without prior opportunity to be heard violated Fifth Amendment. Court decisions and voluntary regulations changes by Secretary resulted in new due process protections, applied nationwide. Plaintiffs awarded \$40,000 in attorney's fees under Equal Access to Justice Act.

<u>Flint v. U.S. Dep't. of Agriculture</u>, 39 F. Supp. 2d 418 (D. VT, 1997)

- In this action for declaratory and injunctive relief, plaintiffs' claim for Homestead Protection was ruled as moot following USDA's grant of the requested relief; plaintiffs were denied leaseback/buyback protection.

Widmer v. SSA Secretary, No. 1:02-CV-265 (U.S. Dist. Ct., D. VT 2005).

- In this Social Security disability/Supplemental Security Income (SSI) case, not atypical of a number of other cases in my caseload, the U.S. District Court in 2005 affirmed an Appeals Council reversal of an ALJ decision rendered in 1999. An interim SSI application proved successful after hearing, paving the way for a favorable decision on the client's older case-in-chief. Attorney's fees were awarded under the Equal Access to Justice Act.

Turco v. Department of Employment Security, 141 Vt. 135 (1982)

- Vermont Supreme Court affirmed Board decision finding that claimant had good cause for leaving employment due to harassment by fellow employees for his religious beliefs.

<u>In re M.L.C.</u>, No. 84-048 (Vt. Supreme Court, <u>dismissed as moot</u>, 1985)

- Challenge to Vermont emergency involuntary civil commitment statute as unconstitutionally vague. Briefed and argued; dismissed as moot upon appellant's discharge from state hospital.

Skudlarek v. Department of Employment and Training, 160 Vt. 277 (1993)

- In a case of first impression in Vermont, the Supreme Court reversed a Board decision denying benefits to a part-time worker who quit when employer unilaterally increased her hours to full-time.

Elaine Howard, Clara Parker and Carolyn Clark v. Department of Social Welfare, 163 Vt. 109, 655 A.2d 1102 (1994)

- In a win of first impression under ADA, the Vermont Supreme Court held that state welfare agency is required to make "reasonable modifications" in ANFC (AFDC) state eligibility criteria in order to avoid violating the Americans With Disabilities Act. At issue was a state regulation which, exactly tracking federal eligibility criteria, denied ANFC to eighteen-year-old students not expected to graduate by age nineteen, while extending it to students expected to so graduate. Appellants' children all suffered from learning disabilities that caused their retention in school and late graduation.
