PUBLIC INTEREST LITIGATION

Served as lead or co-lead counsel on over 200 cases involving natural resources, wildlife protection, public lands management, land use and constitutional law in federal courts in Montana, Oregon, Wyoming, Colorado and South Dakota, the Eighth, Ninth and Tenth Circuit Courts of Appeal, U.S. Supreme Court, numerous state district courts in Montana, and the Montana Supreme Court. A summary of select, published decisions is listed below.

NEPA

WildEarth Guardians v. Montana Snowmobile Assn., 790 F.3d 920 (9th Cir, 2015), EIS overturned for failing to consider impacts from snowmobiles; first appellate decision for failure to apply travel planning restrictions to motorized recreational use of public lands.

Northern Plains Resource Council v. Surface Transportation Board, 688 F.3d 1067 (9th Cir. 2011). Decision to build largest new rail project in U.S. overturned based on inadequate EIS and SEIS.

Clean Water Act

Northern Cheyenne Tribe et al v. Montana Department of Environmental Quality, 234 P.3d 51 (Mont. 2010). Tribe and ranchers overturned NPDES permit for failing to include Best Available Technology limiting coal bed methane water pollution.

Clark Fork Coal. v. Dep't of Env'tl. Quality, 197 P.3d 482 (Mont. 2008). Montana Pollution Discharge Elimination System Permit voided because the state failed to take a hard look at impacts from granting

a perpetual discharge of mine waste pollutants without conducting anti-degradation review.

Northern Plains Resource Council v. Fidelity Exploration and Production Company, 325 F.3d 1155 (9th Cir. 2003), *cert. denied*, 540 U.S. 967 (2003). Energy company held liable under Federal Clean Water Act for discharging coal bed methane waste water, a case of first impression.

Friends of the Wild Swan v. U.S. EPA, 130 F. Supp. 2d 1207 (D. Mont. 2000), *aff'd*, 2003 Lexis App. 15271 (July 25, 2003). Pursuant to 33 U.S.C. § 1313(d), of the Clean Water Act, the district court ordered EPA and Montana to prepare Total Maximum Daily Loads (TMDLs) on all impaired streams by 2007. Affirmed on appeal.

Endangered Species Act

Greater Yellowstone Coalition v. Servheen, 672 F.Supp.2d 1105, *aff'd* 665 F.3d 1015 (9th Cir. 2011). Fish and Wildlife Service's decision to delist grizzly bears overturned, grizzly bears ordered relisted.

State of Wyoming v. U. S. Dept of the Interior, 360 F. Supp. 2d 1214 (D. Wyo. 2005), *aff'd*, 442 F.3d 1262 (10th Cir. 2006). Conservation groups intervened on behalf of federal government to successfully defend a challenge by Wyoming to force the de-listing of wolves under Section 4 of the ESA.

Friends of the Wild Swan v. U.S. Fish and Wildlife Service, 945 F. Supp. 1388 (D. Or. 1996). Court invalidated the U.S. Fish and Wildlife Service's failure to list bull trout under the ESA. The Ninth Circuit reversed an initial ruling that the case was moot. 81 F.3d 168 (9th Cir. 1996).

Friends of the Wild Swan v. U.S. Fish and Wildlife Service, 12 F. Supp. 2d 1121 (D. Or. 1997). Summary judgment was granted for plaintiffs in a follow-up case under the ESA over the remaining populations of bull trout, resulting in listing of all remaining populations in the western United States.

Indian Environmental Law

Glacier-Two Medicine Alliance, et al., 88 Interior Board of Land Appeals, 133 (IBLA 85-445, August 9, 1985); *National Wildlife Federation et al. v. Robertson* (D. Mont. 1994). Represented Blackfeet traditionalists under American Indian Religious Freedom Act, National Historic Preservation Act and environmental laws to protect traditional religious uses in Badger-Two Medicine area.

Hagener v. Wallace, 47 P.3d 847 (Mont. 2002). The Montana Supreme Court enjoined transfer of game farm elk to Crow Nation for release into the wild, because of disease posed by release of captive animals. Regulations upheld under Commerce Clause and failure of Crow to intervene.

Montana Environmental Law

Montana Env'tl. Info. Cent. v. Montana Dep't of Transp., 298 Mont. 1, 2000 MT 5, 994 P.2d 676 (Mont. 2000). In a case of first impression, the Court required Supplemental Environmental Impact Statement under the Montana Environmental Policy Act for a transportation project.

Ravalli County Fish and Game Ass'n v. Department of State Lands, 273 Mont. 371, 903 P.2d 1362 (Mont. 1995). A landmark case establishing the Montana Environmental Policy Act's mandatory requirements and adopting federal jurisprudence to evaluate significant impacts.

Water Law

Bitterroot River Protective Ass'n v. Bitterroot Conservation Dist., 346 Mont. 507, 2008 MT 377, 198

P.3d 219 (Mont. 2008). Landmark case affirming constitutional basis for stream access, halting efforts to privatize stream. Attorney fees awarded under Private Attorney General Doctrine because of constitutional significance of case, 2011 MT 51.

Bitterroot River Protective Ass'n. v. Seibel, 108 P.3d 118 (Mont. 2005). Conservation group's objections to four water rights claims upheld, landowner filed "strawman" applications to avoid basin closure.

Montana Wildlife Law

Spoklie v. Mont. Dept. of Fish Wildlife and Parks, 56 P.3d 349 (2002). The Montana Supreme Court overturned an injunction granted preventing enforcement of I-143, an initiative restricting game farms.

Sportsmen for I-143 v. Montana Fifteenth Judicial District, 40 P.3d 400 (2002). The Montana Supreme Court granted a writ of supervisory control ordering district court to allow sportsmen's organizations and ballot initiative sponsors to intervene in case challenging application of the statute.

Montana Land Use

Aspen Trails Ranch v. Simmons, 356 Mont. 41, 2010 MT 79, 230 P.3d 808 (Mont. 2010). Landowners successfully challenged approval of preliminary plat of subdivision based on an inadequate environmental assessment.

Citizens for Responsible Development v. Bd. of County Com'rs of Sanders County, 351 Mont. 40, 2009 MT 182 (Mont. 2009). Represented citizen group and successfully challenged approval of major subdivision based on an inadequate EA that violated the Montana Subdivision and Platting Act.

Flathead Citizens for Quality Growth v. Board of Adjustment, 175 P.3d 282. Citizens group successfully challenged local government decision to allow gravel pit in residential area, without adequately considering growth policy and adverse impacts of the operation.

Public Land Management Agencies

McFarland v. Kempthorne, 464 F. Supp. 2d 1014, *aff'd* 545 F. 3d 1106 (9th Cir. 2008). National Parks and Conservation Association intervened with Glacier National Park, successfully defending a decision to not allow snowmobile access to private land inholder.

Montana Wilderness Ass'n. v. U.S. Forest Serv., 146 F. Supp 2d 1118, *aff'd* in part, *rev'd* in part, 314 F.3d 1146 (9th Cir. 2003); reversed and remanded 124 S. Ct. 2870; amended complaint granted, October 10, 2005, case settled 2007. The case established substantive agency duties to protect wilderness study areas under the Montana Wilderness Study Act of 1977.

Sierra Club v. Forest Serv., 258 F.3d 1281 (10th Cir. 2001). The Forest Service violated the Norbeck Wildlife Preserve Organic Act by authorizing timber sales within the Preserve without first protecting game animals and birds.

Federal and Montana Constitutional Law

Kafka et al. v. Montana Dep't of Fish Wildlife and Parks et al., 348 Mont. 80, 2008 MT 460, 201 P.3d 8 (Mont. 2008), *cert. den.* 130 S. Ct. 394 (2009); *Buhmann v. State of Montana*, 348 Mont. 205, 2008

MT 465, 201 P.3d 70 (Mont. 2008). Represented ballot initiative sponsors; Court held that I-143 was not an unconstitutional, compensable taking of game farm animals, licenses or real property.

Seven-Up Pete Joint Venture v. Montana, 327 Mont. 306, 2005 MT 146, 114 P.3d 1009 (Mont. 2005), *cert. denied*, 546 U.S. 1170 (2006). Successful ballot initiative banning cyanide heap leach mining not a constitutional taking of the mining company's lease rights.

Spoklie v. State of Montana, 411 F.3d 1051 (9th Cir. 2005). Conservation groups intervened with State to defend game farm law against takings, equal protection, due process, and commerce clause claims. Ninth Circuit denied all constitutional claims, holding I-143 a valid police power statute.

Montana Env'tl. Info. Ctr. v. Montana Dep't of Env'tl. Quality, 296 Mont. 207, 1999 MT 248, 988 P.2d 1236 (Mont. 1999). Co-author of amicus brief that successfully argued Montana's constitutional right to a clean and healthful environment was a fundamental, constitutional right.
