SCHOLARSHIPS AND FINANCIAL AID

Paying for a graduate education doesn't have to be daunting. At VLGS, we are here to help you navigate the process so you can achieve your educational goals.

SCHOLARSHIPS

Merit awards are given annually to entering students who demonstrate excellent academic achievement and promise. Merit-based awards are awarded at the time of admission and are included in your offer letter. All scholarships are awarded based on the program into which a student matriculates. Should a student change program or status, scholarship awards will be reconsidered and re-awarded (if applicable). More details on your scholarship can be found in your scholarship letter. FINANCIAL AID

If you plan to request federal aid, please complete your FAFSA as soon as you receive your acceptance (VLGS school code: G11934). The FAFSA can be completed at **studentaid.gov**. FAFSAs should be submitted no later than August 1. We recommend that students starting in the fall complete the FAFSA by April 1.

All federal loans must be accepted by August 15. Promissory Notes and Entrance Counseling must be received no later than August 20.

If you have concerns about your credit for the GradPLUS loan, please contact the Financial Aid Office at **finaid@vermontlaw.edu** before you submit your seat deposit. If you have VA, Coast Guard, National Guard, or AmeriCorps benefits, please contact Deb Becker at **dbecker@vermontlaw.edu** as soon as you receive your acceptance.

The Financial Aid Office is available to answer your questions about funding your education outside of VLGS scholarships and to assist you throughout the process of applying for aid.

HOUSING

MEALS

We eat well at VLGS. Our campus Café offers breakfast and lunch inspired by a variety of cuisines with options to satisfy a range of dietary needs. Even better, 85% of the food served at the Café is locally sourced and organic. We also offer grab-and-go coolers with 24-hour access to make sure you are never without food options. VLGS also has a student pantry with free food.

Off-campus, local eateries embrace Vermont's whole-foods culture. Think craft beer and burgers made with grass-fed beef. Vegetarian and vegan options are aplenty, too. In the warmer months, take advantage of the local farmstands and CSAs (community supported agriculture) for farm-fresh veggies, dairy products, meats, bread, and more.



FITNESS AND RECREATION

Vermont is our playground. Students hike, bike, run, ski, snowboard, kayak, canoe, and sail. Stop by our Gear Shed to find what you need for your next outdoor adventure.

Indoors, the on-campus fitness center is equipped with weight-training equipment, rowing machines, stair-steppers, and free weights. Student- and staff-led classes in yoga, dance, and martial arts are held weekly. VLGS students also have access to the athletic facilities at Vermont State University's Randolph campus for a fee.

Intercollegiate programs in rugby, basketball, and ultimate frisbee are also available, as are intramural ice hockey, volleyball, and soccer.

BARRISTER'S BOOK SHOP

Barrister's Book Shop is a student-run nonprofit organization and is one of the few independent college bookstores. Barrister's has every book you will need including the best selection of new and used books. All proceeds go towards scholarships for VLGS students pursuing public interest work in the summer.
