Notice of VLGS Amendment to the Academic Regulations

Effective: Thursday, May 1, 2025

Students Effected: Effective immediately upon approval by faculty.

Amendment Type: Revised Academic Regulations

Amendment Description:

In sum, the proposed section X revisions would establish a new graduate-level credential category for Graduate Certificates. In conjunction with this revised section organization, the Professional Certificate in Restorative Justice (PCRJ) program would become the first VLGS Graduate Certificate offering, called the Graduate Certificate in Restorative Justice (GCRJ).

Unlike the current Professional Certificate offering with no academic standing requirement, the proposed Graduate Certificate program would require a cumulative average above a 1.0 upon completion of 6 or more credits, and a 2.3 average to complete the program. This new policy aligns with our Master's degrees academic standing requirement, is intended to maintain the integrity and quality of the program, ensuring that students meet the necessary academic standards to succeed.

The proposed changes will help the Graduate School more effectively market our Restorative Justice programming and position it as a recognized graduate credential, while also providing flexibility to develop and offer other credit-bearing certificates in areas where we want to grow.

REVISED LANGUAGE

Replace academic regulation section X with the following text:

X. GRADUATE CERTIFICATE PROGRAMS

Vermont Law and Graduate School awards Graduate Certificates as described below. Graduate Certificates differ from the certificates earned by JD students as part of their JD concentrated field of study.

A. GENERAL PROVISIONS

The requirements in subsections X.A and X.B of this regulation apply to all Graduate Certificates.

1. GENERAL LIMITATION

- a. Graduate Certificate credits may not be counted towards a Juris Doctorate (JD) or Master of Laws (LL.M.) degree.
- b. A student may only obtain one Graduate Certificate from Vermont Law and Graduate School.

2. REQUIREMENTS FOR GRADUATE CERTIFICATES

- a. Graduate Certificates require a minimum of nine credits and a maximum of 12 credits. Approved Graduate Certificate course credits may be transferred to the Master's degree programs. JD students who want to pursue Graduate Certificates need to earn the certificate credits independently of and in addition to any other courses they take as part of the JD program.
- b. Students pursuing a Graduate Certificate may elect their courses in either a residential or online format or both from the following list of approved courses.

3. DURATION OF PROGRAM

A student who matriculates into the Graduate Certificate program must complete the program requirements in no longer than two years from the date of matriculation. A matriculated student enrolled in a Graduate Certificate program who decides to pursue a VLGS Master's degree will have five (5) years from the date of original certificate program matriculation to complete the Master's degree.

4. ADD/DROP AND WITHDRAWAL POLICIES

B. GRADES AND ACADEMIC STANDARDS

1. ACADEMIC DISMISSAL

- a. A student will be dismissed from the Graduate Certificate program if:
- (1) The student has a cumulative average of 1.0 or below upon completion of 6 or more credits; or
- (2) The student's cumulative average is below 2.3 at the completion of the program.

C. GRADUATE CERTIFICATE IN RESTORATIVE JUSTICE (GCRJ)

1. REQUIRED CURRICULUM

a. A minimum of 9 credits is required for the GCRJ.
