### **Our Class:**

This course is designed to introduce you to a lawyer's obligations—individually, and as a member of the legal profession—to the world in which you will soon work. We will discuss the ethical concerns inherent in the practice of law, as well as duties to clients and consequences for failing to satisfy those duties. We will look at all of this through a lens of the legal profession right now, with discussions of economic pressures, technological advancements, and shifts in public trust brought about by uncertainty in the rule of law.

A lawyer's work largely turns upon relationships; between lawyer and client, but also in connections with other lawyers, professionals, and society in general. This course offers you a chance to reflect on the lawyer you will become as you are building relationships (and building on relationships you started before or during law school).

I consider it to be *my* professional responsibility to do everything I can to ensure you are ready to face the ethical challenges (and other challenges) you will face as a lawyer. I commit to listening to feedback, tackling hard questions, and offering compassion and grace. I expect the same of everyone I work with professionally, including my students.

This is a residential course, and we will meet during our scheduled class time each week with a few exceptions:

- On occasion, if I am sick or have a family emergency, I may need to teach class virtually
- The day of the MPRE, and the day before Thanksgiving, I will cancel class.

During our time together (Mondays & Wednesdays, 2:10-3:25PM EST), frequently we will work together on problems, hypos, and simulations. We will also have guest speakers during the latter part of the semester. Be prepared to engage; this will not be a passive class.

## **Learning Objectives:**

By the end of this course, students will be able to:

- Understand the framework of professional responsibility, and explain the structure of lawyer regulation in the U.S.
- Identify and resolve ethical dilemmas: apply the ABA Model Rules and relevant comments, evaluate competing duties, and propose reasoned, defensible courses of action
- Develop professional judgment: integrate rules, professionalism principles, and client-centered thinking, to make sound decisions in practice settings
- Prepare for the MPRE and demonstrate readiness for ethical-decision making in everyday lawyering
- Reflect on professional identity: articulate the values, responsibilities, and personal principles that will guide them in developing their identity as a lawyer

### The MPRE:

Some of you will sit for the MPRE this semester (November administration on 11/12-11/13). We will dedicate a day in November before the MPRE to review strategies for approaching MPRE questions, practice timing drills, and debrief common mistakes. In addition, short question sets will be available in Canvas each week to build familiarity with question formats and common traps.

#### Assessment:

Your grade for the course will be based on a combination of participation, a midterm, and a final exam, with optional quizzes or short reflections.

- *Participation* (15%): Being prepared for and actively engaging in on-call discussions; thoughtful contribution to small-group activities; constructive engagement with classmates and respect for others' perspectives
- Midterm (30%): Short essay and multiple choice
- Final Exam (50%): Short essay and multiple choice
- Assessments/Essays (5%): Complete either quizzes on Canvas, or write two, 300-400 word reflections on topics such as, lessons learned from guest speakers, ethical issues encountered in clinical, internship, or work settings, or current debates in attorney regulation

**Accessibility:** Having the right environment in which to absorb and retain information is critically important. To that end, the following guidelines will be followed in the Canvas course and the classroom, in person and virtual:

- **Freedom to Roam**: If you need to get up and go potty, stand and listen, stretch your legs, wander, discharge nervous energy, focus your mind, etc., feel free to move around and do so at any time during class without announcing yourself.
- **Class Recordings**: Recordings with a transcript will be made of each lecture, and posted to the class Canvas page after class.
